TERMS AND CONDITIONS

No correspondence received concerning this promotion will be entered into.
3. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with this promotion are ineligible to enter. 7. For the purposes of these Terms and Conditions, the following definitions apply:
'Purchase' means order placed and payment made in full for the Electrolux Spare Part type or accessory during the Promotional Period from an 'Participating Authorised Electrolux Spare Parts Distributor'.
'Participating Authorised Electrolux Spare Parts Distributor' means only partners of Electrolux (including online retail partners) approved by Electrolux Home Products within Australia.

"Purchase" does not include:
 - (i) Orders not paid in full;
 - (ii) Second hand products;

- (iii) Electrolux staff and the staff's immediate family purchases;
- (iv) Purchases made in conjunction with any other promotion;
- (v) Purchases made directly from EHP Pty Ltd; and
- (vi) Purchases made through any unauthorised retailer.
